**Stray Round Registration for UG NEET BASED COURSES
for Vacancies under GOVERNMENT / MANAGEMENT / NRI QUOTA**

ROUND 3 admitted list and vacancy position for UG NEET based courses under Government, Management and NRI quota have been published on the CENTAC website www.centacpuducherry.in.

Stray Round Registration for the vacancies published in CENTAC website for admission in UG NEET based courses is open. Using dashboard login credentials, candidates can **register** after referring to vacancy positions published in CENTAC website.

For **Stray Round admission** to the first year MBBS, BDS & BAMS (Ayurveda) & B.V.Sc.&A.H. (National SS) / NRI courses in Government and Self Financing Medical, Dental & Ayurveda colleges in the UT of Puducherry, submission of willingness, link for **payment of Full tuition fees for MBBS or Registration fees as prescribed for BDS/B.V.Sc.&A.H./BAMS** and filling of Course Preferences under Government, Management (MQ) and NRI Quota **will be enabled from 25.10.2024 to 28.10.2024, 5.00 pm.**

Eligibility for Registering Stray Vacancy Round

All candidates EXCEPT

1. Candidates who are in admitted status in Round 3 (joined in Round 1 or Round 2 also) in All India Quota or State Quota.
2. Candidates who have been allotted any seat in Round 3 or in any Stray round in All India Quota or State Quota not joined.

Submission of Willingness, Payment, Declaration and Course Preferences

The candidates may participate after submitting willingness, payment of Full Tuition fees / Registration Fee as applicable and filling of Course preferences before **28/10/2024, 5.00 PM**. If course preferences list is empty, the candidate will NOT be considered for allotment.

Further the candidate is requested to submit a Declaration form attached herewith as in **Annexure-I.14 of UG-NEET Brochure**, failing which the candidate will NOT be considered for Allotment.

INSTRUCTIONS FOR PAYMENT OF REGISTRATION FEES

1. Candidates opting for M.B.B.S. need to pay FULL TUITION FEE as mentioned above.
2. Candidates opting for BDS/BAMS/B.V.Sc&AH need to pay Registration Fee as mentioned above.
3. Only those Candidates who pay the full Tuition Fee / Registration fee (including SC/ST candidates) will ONLY be considered for STRAY ROUND.
4. For those candidates who paid Registration Fee and were **NOT allotted a seat in Round 3** need to pay the balance of Full Tuition Fee /Registration Fee, as applicable, for Stray Round and submit course preferences.

To participate in the STRAY ROUND counselling, the candidates are required to pay the Full Tuition Fee fixed as below:

To participate in the STRAY ROUND counselling, the candidates are required to pay the Registration Fee fixed as below:

The candidates are requested to transfer the registration fee to CENTAC account through NET BANKING or by generating NEFT / RTGS (preferably RTGS) challan using the payment link in their dashboard login credentials and proceed for payment. Read the HELP Instructions carefully before proceeding for payment.

Refund / Forfeiture of Fees paid for Stray round

- In case the candidate is not allotted any seat during Stray round, the Full Tuition Fee / Registration fee paid as applicable, will be refunded to the same account of the candidate from which payment had been made.
- Otherwise, if seat is allotted and the candidate does not join the course, the Full Tuition fee / Registration fee amount will be forfeited and such candidate will be debarred from taking NEET exam next year.
- If candidates is ALLOTTED a seat in STRAY round and joins the allotted seat the registration fee will be adjusted against the Tuition fee, if any.
- Therefore, it is advised that the candidate makes a thoughtful decision before submitting course preferences for stray vacancy counselling.
