NOTE - Stray Vacancy Round-2 - PG Medical - 2024

Online Registration, Verification of documents and seat allotment – after further lowering of NEET PG 2024 Cut-off percentile for PG Medical seats.

NBEMS, New Delhi, in its notice dated 25-02-2025 has further reduced qualifying criteria to “5th Percentile” for all categories of candidates for admission to PG Medical courses. Please note that SC/ST/OBC eligibility criteria are applicable to Karnataka SC/ST/OBC candidates only.

Interested and eligible candidates can register, apply online and pay the fees to become eligible to participate in the Stray Vacancy Round-2 along with other eligible candidates for the available seats only (seats available is hosted on the KEA Website – Keep visiting Website for updates). Schedule and activities are as follows:

i.	Commencement of Registration and filling of Application Online	From 7.00 pm on 01-03-2025
ii.	Last date to fill the application online	04-03-2025 up to 6.00 pm
iii.	Last date to pay the application fees – online	05-03-2025 – 9.00 am
iv.	Verification and deposition of original documents at KEA, 18 th Cross, Malleshwaram, Bangalore.	03-03-2025 to 05-03-2025 (10.30 am to 2.00 pm)
v.	Payment of Caution Deposit of Rs.5,00,000/- after verification and deposition of original documents.	04-03-2025 to 06-03-2025.
vi.	Subsequent schedule will be published in the KEA Website; candidates should keep visiting Website for updates.	

PG Medical candidates who were eligible earlier but did not register can also register, complete the application process and appear for verification and deposition of original documents.

1. The academic eligibility criteria as laid down in NEET-PG 2024 Information Bulletin and other conditions are hosted on the KEA Website for the information of the candidates. Original documents to be produced for verification are detailed in the NEET-PG 2024 Information Bulletin.
2. Candidates should ensure that they are having all the original documents and carrying the same with them for verification and deposition at KEA, Bangalore.
3. All Originals and two set of photocopies to be produced along with final print of the application form, PGNEET-2024 Score Card, Identity card, Annexure.
4. Documents will not be verified for the candidates who fail to produce all the mandatory / required original documents as per their eligibility and they will not be eligible to participate in the Stray Vacancy Round.
5. Candidate should come personally for verification and no one can represent them.
