BDS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2024-25

NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR SECOND PHASE COUNSELING.

In continuation to this office notifications dated: 03-08-2024, 12-08-2024 and 27-08-2024, 21-09-2024, 24-09-2024, 26-09-2024, 28-09-2024, 03-10-2024 and 07-10-2024 KalojiNarayana Rao University of Health Sciences hereby notifies the conduct of second phase ofweb based counseling for vacant seats under Competent Authority Quota (C.Q) for BDS course including PWD, Anglo Indian, CAP categories for 2024-25 in Government, Private Dental Colleges and Army Dental College in the State of Telangana.

Candidates whose names are notified as eligible candidates in the provisional final merit list of MBBS/BDS Admissions on the KNRUHS website on 26-09-2024 and addendums are eligible to exercise web - options online from computer with internet connection.

All the eligible candidates whose names are displayed in the Provisional final merit list including PWD, PMC, Anglo-Indian and CAP category candidates and addendums on KNRUHS website can exercise web options for admission into BDS seats from **6.00 A.M. on 08.10.2024 to 12.00 NOON on 09.10.2024** through website <https://tsbdsadm.tsche.in/> subject to following conditions:

1. The Candidates who were allotted seats in the first phase of counseling and have not reported/discontinued the course at the respective college are not eligible for exercising options.
2. Candidates who have not exercised web options in the first phase of counseling are not eligible to exercise web options.
3. The candidates who were allotted BDS seats in the first phase of counseling and joined the course and continuing in the course are eligible to exercise web options and are informed to exercise web options.

For eligibility criteria and regulations refer to notifications dated: 03.08.2024.

UNIVERSITY FEE

Allotted Candidates have to pay University fee of Rs. 12,000/- for BDS Course through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter. Candidates who have paid University fee in the first phase need not pay again.

TUITION FEE: Tuition fee payable is as notified by Government

NOTE:

1. The details of vacant seats available (seat matrix) are placed in the website <http://knruhs.telangana.gov.in> . Candidates can exercise web options for BDS seats in all Dental colleges affiliated to KNRUHS through <https://tsbdsadm.tsche.in/>
2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, G.O. Ms. No. 125, Health, Dental and Family Welfare (C1) Department Dated: 22.09.2022, G.O. Ms. No. 75, Health, Dental and Family Welfare (C1) Department Dated: 04-07-2023, G.O. Ms. No. 33, Health, Dental and Family Welfare (C1) Department Dated: 19-07-2024 and relevant Hon'ble High Court/Supreme court orders and University regulations.
3. Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website before exercising web options.
4. **Candidates are informed that if they exercise web- options for a seat and allotted a BDS seat as per their choice in the web- counseling and if they do not join the course at the allotted college, they will not be eligible for exercising web- options for subsequent rounds of counseling.**

IMPORTANT INSTRUCTIONS TO THE CANDIDATES:

- 1) Eligible NEET-UG-2024 qualified candidates as per provisional final merit list for Competent Authority Quota can exercise web options for BDS seats in Dental colleges as per their interest and priority through <https://tsbdsadm.tsche.in/> from computer with internet connection.
- 2) Candidates are advised to go through the Prospectus for the Regulations for MBBS/BDS course on KNRUHS website before exercising web-options.
- 3) If a candidate is allotted a seat in BDS course as per his/her options and does not join the course, they shall not be permitted to exercise web options in subsequent phases of counseling and admission to prevent seat blocking.
- 4) Candidates exercising web-options for BDS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per candidate's eligibility. **If candidates are not interested to join in any college, they should not exercise web options for the same.**
- 5) Candidates are advised to exercise web options for BDS seats in all colleges in which they are interested to join irrespective of available vacant seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in first phase of counseling to other seats as per their web options in the second phase of counseling.
- 6) **If a seat is allotted in this phase of counseling as per web options exercised by the candidate in this phase of counseling, the seat allotted in 1st phase of counseling will be automatically cancelled and allotted to the other candidate. Therefore, candidates are informed to exercise web options carefully for sliding with awareness of this fact.**
- 7) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read construction to the candidates before giving options)
- 8) Candidates are instructed to take a print out of saved options.

- 9) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are directed to login to check their allotment status on <https://tsbdsadm.tsche.in/> website after each phase of counseling without fail.
- 10) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective Dental College on or before the date specified on the allotment letter.
- 11) Selected candidates have to report to the Principal of the respective Dental College before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and the candidate's options shall not be considered for subsequent phases of counseling and admission to prevent seat blocking.
- 12) If the candidate slides to other college during second phase of counseling in colleges affiliated to KNRUHS, the candidates have to get relieved from first phase joined college, collect original certificates, collect fees and report to the Principal of allotted college before last date of joining. Candidates who do not join the course at the allotted college in this phase of counseling are not eligible for further phases of counseling.
- 13) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted Dental College and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- 14) MCC Information Bulletin states that in supersession to previous counselling scheme, it has been decided by the Competent Authority (MoHFW) that up gradation will be allowed up to Round 3 (Mop Up Round). Hence, candidates

are informed that they will be permitted for upgradation/sliding till Mop Up phase of Counselling. Admitted candidates shall not be permitted to discontinue the course after allotment in Mop Up phase of Counselling.

- 15) Candidates are advised to take a calculated decision of continuing in the Mop Up phase of Counselling as they would not be permitted to resign from allotted seat in Mop up phase of Counselling.
- 16) Original certificates submitted at the time of admissions shall not be returned to candidate, unless the candidate discontinues the course before Mop Up phase of counseling or before the last date for free exit.
- 17) **The University fee once paid shall not be refunded under any circumstances.**
