1. NRI Quota

An Indian Citizen who stays abroad for employment/carrying on business outside India or stays abroad under circumstances indicating an intention for an uncertain duration of stay abroad is a non-resident. (Indian Persons posted in U.N. Organizations and Officials deputed abroad by Central/State Governments and Public Sector undertakings on temporary assignments are also treated as non-residents).

NRI Quota includes:

- 1) Non-Resident Indian (NRI): In case of general public, an individual being Indian citizen or person of Indian origin is said to be NRI in any financial year, if the candidate satisfies both of the following conditions:
 - Candidate resides in India for less than 182 days during previous financial year (OR) who stays outside India for employment or for carrying on business or for any other purpose indicating his intension to stay outside for an uncertain period. An Indian citizen who stays in India for less than 365 days during the four preceding financial years and less than 60 days in that financial year.
- 2) Wards of NRI parents/NRI Students: Non-Resident Indian (NRI) students are Indian Nationals who studied abroad. They must have had at least three years of education in any foreign country during the last 6 years and must have passed the qualifying examination (12th standard or equivalent) from recognized college or institutes located abroad (OR)

This includes Indian students studying in schools or colleges situated in foreign

countries even if they are affiliated to boards of secondary education or universities located in India, but will not include students studying in those schools or colleges (situated in India) or affiliated to the boards of secondary education or universities of the foreign countries.

3) Overseas Citizen of India (OCI)/ Person of Indian Origin (PIO) card holder: The Ministry of Home Affairs vide notification dated 4th March 2021, specified the rights to which an OCI/PIO cardholder shall be entitled under the citizenship act, 1955. Clause (4) (ii) of the said notification reads as under: "(4) parity with NRI in the matter of, (ii) appearing for the all Indian entrance test such as national eligibility cum entrance test Joint Entrance Examination (Mains), Joint Entrance Examination (Advanced), or such other tests to make them eligible for admission only against any NRI seat or any supernumerary seat: Provided the other OCI/PIO Card holder shall not be eligible for admission against any seat reserved exclusively for Indian citizens.

The above notification provides the following explanation: "The OCI Card holder (including a PIO cardholder) is a foreign national holding passport of a foreign country and he is not a citizen of India" similarly, the PIO cardholder and foreign national shall not be eligible for admission against for any seat reserved exclusively for Indian citizens.

4) NRI Sponsored Candidates: The sponsor financing the education of a student must be an NRI and/or blood relation such as spouse, children (natural/adopted/foster), siblings, paternal uncle/aunt, maternal uncle/aunt, paternal grandfather/grandmother, and maternal grandfather/grandmother, paternal and maternal cousins. The sponsor possessing a student/visiting visa or temporary visa of any nature from other countries is not eligible to sponsor. The sponsor must produce the proof of the annual income sufficient to support the course of the study of his/her ward.

1.1 Eligibility

Applicants must belong to one of these categories: 1) Non-Resident Indians, 2) Wards of NRI parents/NRI Students, 3) OCI/ PIO card holder and 4) NRI sponsored candidates.

1.2 Academic Qualifications

The applicant must have passed and secured minimum 50% aggregate in 12th standard (English Medium) from an Indian Board or an equivalent Board outside the country with the subjects of Biology (Botany and Zoology) and Physical Sciences (Chemistry and Physics) for admission into B.V.Sc.& A.H. under NRI quota.

1.3 Age limit

The candidate should have completed 17 years and not crossed 25 years as on 31st December, 2024.

1.4 Application fee

Applicant has to pay non-refundable application fee of Rs. 10,000 (Rupees ten Thousands)

1.5 Criteria for selection under NRI quota

The selection of candidates shall be based on the rank obtained in the NEET (UG) -2024.

General Instructions for NRI candidates:

University may, at its discretion, cancel the admission of a candidate at any time, if it is found that the candidate obtained the admission by misrepresentation/concealment of facts, or the admission was made due to error, oversight, etc.

Candidates applying under NRI / wards of NRI category should submit recent NRI status certificate of the Candidate / Parent / Sponsor issued by the Indian Embassy of the Country concerned with their seal as per Annexure-I as applicable.

2.0 Self-finance quota

2.1 Eligibility

Applicant under Self finance category shall be any citizen of India, who has completed primary and secondary education in India.

2.2 Academic qualifications

The applicant must have passed and secured 50% aggregate marks in 12th standard from an Indian Board or an equivalent Board with the subjects of Biology (Botany and Zoology), physical sciences (Physics and Chemistry) for admission into B.V.Sc.& A.H.

The candidates applying under self-finance quota seats shall qualify in the NEET-UG 2024.

2.3 Age limit

The candidate should have completed 17 years and not crossed 25 years as on 31st December, 2024.

2.4 Criteria for selection for Self-finance quota seats

The selection of candidates under self-finance quota seats shall be based on the rank obtained in the NEET-UG, 2024.

2.5 Rule of Reservation

Rule of reservation as per Govt. of Telangana shall be implemented under self-finance quota seats.

- a) For each extended year of study, an additional fee of Rs.6,00,000/- per annum will be charged.
- b) Fee once paid shall not be returned under any circumstances.
- c) All the legal issues shall be settled under the jurisdiction of Hyderabad only.

4.0 General Information

- 4.1 Candidates suffering from certain disabilities as specified in the Minimum Standards of Veterinary Education Regulations, 2016 of Veterinary Council of India (www.vci.dahd.gov.in) are not eligible for admission.
- 4.2 **Hostel facility:** Hostel facility shall be provided subject to availability of accommodation in the respective colleges. Interested candidates may apply to the Chief Warden of the respective college for hostel accommodation. They have to pay the prescribed fee as per hostel rules. There is no separate hostel for students admitted under NRI/Self-finance quota. The hostel mess is run on dividend system for all students.
- 4.3 All admissions shall be deemed as provisional and subject to further scrutiny. They shall be liable to cancellation at any stage during the study if it is found that an admission is contrary to the rules or invalid by reason of incorrect or false information furnished by the applicants or their parents/guardians at the time of admission. Any cancellation of admission shall not exclude penal action under the relevant criminal law.
- 4.4 RAGGING IS PUNISHABLE AS PER PROCEEDINGS OF HON'BLE SUPREME COURT OF INDIA IN SLP (C) NO. 24295/2004 CONVEYED BY THE UNIVERSITY GRANTS COMMISSION VIDE LETTER NO.F.1-8/2006 (CPP-II) DATED: 04.03.2008. If any incident of ragging comes to the notice of the authority, the concerned student shall be given the liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the Institution.

4.5 All the candidates admitted under these categories should abide by the Academic Rules and Regulations prescribed in the Act, Statutes, Regulations and Rules of the University, which may be subject to revision from time to time.

5.0 General Instructions to the candidates:
