BDS ADMISSIONS UNDER MANAGEMENT QUOTA 2024-25

Notification for exercising web-options for Stray Vacancy phase

In continuation to this office notifications dated: 17-08-2024, 29-09-2024, 03-10-2024, 12-10-2024, 26-10-2024 and 01.11.2024 KNRUHS hereby notifies the conduct of Stray Vacancy phase of web-based counseling for vacant seats after Mop Up phase of Counselling for admission into BDS courses under Management Quota for 2024-25 in affiliated Private **Dental** Colleges.

Candidates who are notified in the provisional final merit list of MBBS/BDS Admissions under Management Quota on the KNRUHS website on 29-09-2024 are eligible to exercise web - options online from computer with internet connection.

All the eligible candidates whose names are displayed in the Provisional final merit list for Management Quota on KNRUHS website can exercise web options for admission into BDS courses from **6.00 PM on 01.11.2024 to 4.00 PM on 02.11.2024** through <https://tspvtmedadm.tsche.in/> as per the candidates registration and eligibility for B & C (NRI) categories subject to following conditions:

1. The Candidates who were allotted seats in the previous phases of counseling under Management Quota are not eligible for exercising options for BDS course.
2. Candidates who have not exercised web options in the first phase of counseling for BDS course under Management Quota are not eligible to exercise web options for that course.
3. Candidates who are allotted BDS seats in Stray Vacancy phase under Competent Authority Quota and MBBS seats in stray vacancy phase under Management Quota are not eligible to exercise web options.
4. Candidates who have joined BDS course under Competent Authority Quota and Management Quota in the previous phases and continuing in the course

are not eligible to exercise web options.

5. Candidates who are admitted under MCC Counselling up to third phase of counselling as notified on MCC website are not eligible to exercise web options.
6. Options of candidates who are admitted in other states as per the data uploaded to MCC portal shall not be considered.
7. Candidates who are allotted seats in MCC Counselling Stray Vacancy phase of counselling as notified on MCC website are not eligible to exercise web options

Candidates will have to exercise web options for the BDS seats in order of preference for colleges and category (B&C/NRI).

UNIVERSITY FEE:

Allotted Candidates have to pay the following University fee through payment gateway by using online payment method (Debit Card/Credit Card/Internet Banking) and down-load the allotment letter.

For B- Category :

BDS Rs,20,000=00

For C-Category (NRI):

BDS Rs. 40,000=00

TUITION FEE: Tuition fee is to be paid at respective Dental colleges.

The tuition fee payable as notified by Government of Telangana in GO Ms No:106, HM& FW (C1) Department, Dated:28. 07.2023 (notified on KNRUHS web site)

NOTE:

- 1) The details of vacant seats available (seat matrix) are placed in the website <http://knruhs.telangana.gov.in> Candidates can exercise web options for BDS seats in all Dental Colleges under KNRUHS through <https://tspvtmedadm.tsche.in/> subject to above stated conditions.
- 2) In accordance with the GO.Ms.No.130 HM&FW (C1) Department, Dated: 27.09.2022 in Management Quota B Category, 85% of seats are reserved for local candidates of Telangana and 15% seats are open to candidates from all over the country. 15% unreserved seats shall be allotted first followed by seats reserved for local candidates in Management Quota B category seats.

- 3) The allotment of seats will be made in accordance with the selection procedure notified in Government Orders G.O.Ms.No. 115 & 116 HM&FW (C1) Dept. Dated: 05-07-2017, G.O.Ms.No.117 & 118 HM&FW(C1)Dept. Dated: 20-07-2017, subsequent amendments, G.O.Ms.No.125, 126, 127, HM&FW (C1) , Department, Dated:22-09-2022, GO.Ms.No.130 HM&FW (C1) Department, Dated:27.09.2022, G.O.Ms.No.33 HM&FW (C1) Department (for Local area), Dated: 19.07.2024, other Government orders, University Regulations and relevant Hon'ble Supreme Court and High Court orders.**
- 4) Candidates are informed that they will be considered only to the category/ categories to which they have registered. (B/NRI)**
- 5) Candidates are informed that if they exercise web- options for a seat and allotted a BDS seat as per their choice in the web- counseling and if they do not join the course at the allotted college, penalty clause shall be applicable including penalty amount of Rs. 20.00 lakhs and debarment for 3 years to prevent seat blocking.**
- 6) Admitted candidates are not permitted to withdraw/discontinue from the course after Mop up phase of counseling. Admitted candidates will have to pay discontinuation penalty amount of Rs.20 lakhs as per Government Orders, if they discontinue the course after the Mop up phase of counseling to get their original certificates back. Candidates also will be debarred for 3 years for BDS admission under KNRUHS to prevent seat blocking**
- 7) Candidates are informed that the allotments/admissions are subject to Orders of Hon'ble Courts in all pending cases.**

IMPORTANT INSTRUCTIONS TO CANDIDATES:

- 1) Eligible NEET-UG-2024 Candidates as per Provisional Final Merit List for Management Quota can exercise web options for vacant seats under Management Quota in all Dental colleges as per their interest and priority from computer with internet connection through <https://tspvtmedadm.tsche.in/>**
- 2) Candidates are advised to go through the Prospectus for the Regulations for MBBS/BDS courses under Management Quota of KNRUHS, available on website before exercising web options.**

- 3) If a candidate is allotted a seat in BDS course as per his/her options and does not join the course, penalty clause shall be applicable including penalty amount of Rs. 20.00 lakhs and debarment for 3 years to prevent seat blocking. If candidates are not interested to join in any college they should not exercise web options for the same.**
- 4) Candidates exercising web-options for BDS courses are informed that there is no limit of choices (number) for exercising web-options. Candidates have to exercise web options for any number of colleges the candidate is interested to join as per candidates eligibility (B/C-NRI) in order of preference.
- 5) Candidates have to exercise options for B category and if eligible for C (NRI) in order of their priority for college. Allotments will be made according to the order of preference in the web options exercised by the candidate.
- 6) Allotment of Management Quota seats in Army Dental College is reserved for the wards of Army personnel as per AWES Regulations.
- 7) Candidates can exercise options on the web either from home / any other place having internet facility. Candidates are instructed to take a print out of saved options.
- 8) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options).
- 9) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are directed to login to check their allotment status on through <https://tspvtmedadm.tsche.in/> website after each phase of counseling without fail.
- 10) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment details and report to the Principal of respective Dental college on or before the date specified on the allotment letter.
- 11) Selected candidates have to report to the Principal of the respective Dental college before the last date for joining as specified on the allotment letter,

submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and penalty clause shall be applicable including penalty amount of Rs. 20.00 lakhs and debarment for 3 years to prevent seat blocking.

12) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.

13) Candidates allotted seat under NRI Quota should produce the relevant sponsorship letter from NRI relative in Original along with copy of passport/ Residence Proof/Bank Statement or pass book of sponsor for NRI Category at respective colleges.

14) Original certificates submitted at the time of admissions shall not be returned to candidate, unless the candidate discontinues the course.

15) The University fee once paid shall not be refunded under any circumstances.
