**ENGINEERING/PHARMACY/ARCHITECTURE/MEDICAL/MEDICAL  
ALLIED COURSES -CANDIDATES CAN VERIFY THEIR PROFILE AND  
RECTIFY DEFECTS**

Candidates who have submitted online application to the Commissioner for Entrance Examinations for the admission to Kerala Engineering/ Pharmacy/Architecture/Medical/ Medical allied courses (KEAM-2026) can verify their profile and rectify the defect, if any, till **10.05.2026, 6.00 PM**. Candidates can view their profile (except NRI Quota related details) page after logging into the '**KEAM 2026 - Candidate Portal**' available on the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in), by providing the login credentials (Application Number and Password).

Candidates can verify the details of the already allowed claims with respect to Nativity, Reservation, Fee Concession, and personal details such as Name, Photo and Signature. Those candidates, who have any defects in their application can view the defects by clicking the menu item '**Memo Details**' provided in the Profile page. Candidates can rectify the defects by uploading valid documents/Name/Photo/Signature as applicable. Candidates who have difference in their Name, Photo and Signature shown in the profile page with their actual name, photo, signature can inform the matter through the e-mail ([ceekinfo.cee@kerala.gov.in](mailto:ceekinfo.cee@kerala.gov.in)) with subject as '**profile defect**' on or before **6.00 PM on 10.05.2026**. Documents/Certificates sent to the Office of the Commissioner for Entrance Examinations by any mode other than through the KEAM-2026 candidate portal, in response to the respective memos or otherwise, will not be considered for any fresh claim.

**Note:**

1. As per the provisions laid down in the Prospectus, only Keralites are eligible for Communal/Special reservation or any fee concession. Those candidates who have not been accorded the nativity status as 'Keralite' will not be considered for any reservation or fee concession. Hence, defects in Nativity proof given in the memo in the 'Candidate Portal' should be

rectified by uploading valid documents even if there is no memo with respect to reservation or fee concession claims if such claims are to be confirmed.

2. Only those candidates who have qualify the entrance examination for Engineering courses and submit the plus two (equivalent) marks online within the stipulated time (to be announced later) will be included in the Engineering rank list.

3. Only those candidates who qualify in the entrance examination for the Pharmacy course will be included in the Pharmacy rank list.

4. Candidates who have claimed eligibility for NRI quota will be given an opportunity to rectify defects, later, through the Candidate portal.
